The best source of information on how COVID-19 is affecting our neighborhood is the Jefferson County website. If you go to <https://www.jeffco.us/4007/COVID-19-Case-Summary> you can see how many cases are being reported by neighborhood in Jefferson County. Click on the Geography tab. They call our neighborhood "Harriman Lake." It appears from the map that this includes Lakehurst and Westfield Park. As of August 21, there have been 117 cases so far, and 11 people have been hospitalized. There have been nine new cases reported in the last two weeks.
